The first of these was the YWPA Award (Young Women in Public Affairs), with the Committee receiving eight (8) applications which they are busy evaluating to make their selection!

#### Career Advancement

This \$1,000 scholarship is offered by our Club to a qualifying woman residing in Clinton County who is updating her skills in a vocational school or to assist in completing her post-secondary education in a college or university.

Applicants must be at least 19 years of age or more at the time of application and must have been admitted to, or cleared for admission to, an academic or vocational school licensed or accredited by the State of Indiana.

Zonta members and their immediate families are not eligible.

## \* Jane M. Klausman Women in Business

This \$500 scholarship will be awarded to a woman undertaking business studies who has demonstrated outstanding potential in the field. Any woman undertaking a business program at an accredited university/college/institute, including online students, in at least the second year of an undergraduate program through the final year of a Master's program at the time the application is submitted, is eligible to apply.

The winning applications at our Club level will be sent to District competition for an additional \$2,000 award and if successful, the application would then be forwarded to Zonta International Foundation for consideration of another award of \$8,000. The application and other information can also be found at Zonta.org.

A friendly reminder that club members and their family members (*ancestors*, *descendants*, *adoptees*, *siblings*, *and those of their spouse*) are not eligible to apply, following the award rules from the Zonta International Foundation.

\* Applicants for this award at the Club level must reside in and/or claim residency in Clinton County.
